(c) The show shall run in a **punctual manner**. If the event is running late, the client will discuss possible time changes with the performers. If show begins late and ends after the agreed upon time additional fees may be applied. Performer(s) will be paid an additional \$25 each, for every half hour the show is extended. Due to other obligations and performances that may be scheduled, the performer(s) may not be able to extend show times; details must be agreed upon between the client and performer(s) if

there is time extension. Late start to a show may result in a shorter show or constitute a breach of contract on the part of the client.

- **(d)** If appropriate, the performer(s) will encourage audience participation through dancing and belly dance instruction. Guests of honor may be invited onto the stage to dance, but the performer(s) **will not force** those who are uninterested in participating.
- (e) The performer(s) shall provide music in the form of a CD or ipod

- (d) A safe and adequate space for the performer shall be provided. Please make sure floor or stage space that is clean and hazard free from any broken glass, spilled liquids, or any other objects that may be in the way. This also includes an environment that is free of harassment of a sexual nature or otherwise. If the environment is proven unsafe by the performer(s) or anyone else for any of the above reasons, the performer(s) may leave without rendering services. In the event that harassment in any form is encountered during the a performance, it is within the discretion of the performer(s) to end the show at that time. In these rare circumstances, the client will still be responsible for paying the full amount.
- **(e)** A **sound system** with CD playing capabilities shall be provided, preferably in the same room in which the performance is to take place. The sound system is an important part of the show and should be tested prior to the arrival of the performer(s). Louder is better for dancers, especially when they are playing finger cymbals.
- (f) The client shall **communicate any special suggestions or requests** prior to the beginning of the performance. The performance has been carefully choreographed and it is difficult to make changes once the performance has begun. Be assured that, if appropriate, audience participation song(s) will be included. It is also a safety hazard to have children wondering up to the dance floor. Small children are hard to be seen when spinning or using props such as a sharp sword. Dancer(s) will not be held responsible for children that may get hurt while approaching the dance floor. Participation with children should be requested as with audience. We will set up the music accordingly for all to join if requested.

(g) A safe and private space will be provided for the performer(s) to change clothes and to store their bags while performing. Costumes are ve expensive. If any have been lost, damaged or stolen, client will have to reimburse Sevdije Inc. Also some shows require elaborate and quick costume changes, so arrangements with the performer(s) for changing are must be made prior to show time.
